Standard of Passing:

For all courses, both UE and IA constitute separate heads of passing. In order to pass in such courses and to earn the assigned credits, the learner must obtain a minimum grade point of 5.0 (40% marks) at UE and also a minimum grade point of 5.0 (40% marks) at IA.

If a student fails in IA, the learner passes in the course provided he/she obtains a minimum of 25% in IA and GPA for the course is at least 6.0 (50% in aggregate). The GPA for a course will be calculated only if the learner passes at the UE.

A student who fails at UE in a course has to reappear only at UE as a backlog candidate and clear the head of passing. Similarly, a student who fails in a course at IA has to reappear only at IA as a backlog candidate and clear the head of passing.

The 10-point scale Grades and Grade Points according to the following table.

The performances at UE and IA will be combined to obtain the Grade Point Average (GPA) for the course. The weights for performance at UE and IA shall respectively be 60% and 40%.

GPA is calculated by adding the UE marks out of 60 and IA marks out of 40. The total marks out of 100 are converted to grade point, which will be the GPA

Formula to calculate Grade Points (GP)

Suppose that 'Max' is the maximum marks assigned for an examination or evaluation based on which GP will be computed. In order to determine the GP, Set x = Max / 10 (since we have adapted 10-point system). Then GP is calculated by the formulas shown as below.

Range of Marks at the evaluation	Formula for the Grade Point
$8x \le \text{Marks} \le 10x$	10
$5.5x \le Marks < 8x$	Truncate (Marks $/x$) + 2
$4x \le \text{Marks} < 5.5x$	Truncate (Marks $/x$) + 1

Two kinds of performance indicators, namely, the Semester Grade Point Average (SGPA) and the Cumulative Grade Point Average (CGPA) shall be computed at the end of each term. The SGPA measures the cumulative performance of a learner in all the courses in a particular semester, while the CGPA measures the cumulative performance in all courses since his/her enrolment. The CGPA of learner when he/she completes the programme is the final result of the learner.

The SGPA is calculated by the formula SGPA= $\frac{\sum Ck \times GPk}{\sum Ck}$, where C_k is the credit-value assigned

to a course and GP_k is the GPA obtained by the learner in the course. In the above, the sum is taken over all the courses that the learner has undertaken for the study during the semester, including those in which he/she might have failed or those for which he/ she remained absent. **The SGPA shall be calculated up to two decimal place accuracy.**

The CGPA is calculated by the formula CGPA = $\frac{\sum Ck \times GPk}{\sum Ck}$, where C_k is the credit-value

assigned to a course and GP_k is the GPA obtained by the learner in the course. In the above, the sum is taken over all the courses that the learner has undertaken for the study from the time of his/her enrolment and also the during the semester for which CGPA is calculated, including those in which he/she might have failed or those for which he/she remained absent. **The CGPA shall be calculated up to two decimal place accuracy.**

The Formula to compute equivalent percentage marks for specified CGPA:

- A grand total of marks obtained by the students under all the heads of passing shall not be considered as a separate head for passing.



Course: M. D. (Hom.) (Doctor of Medicine in Homoeopathy)

(2016 Course)

Standard of Passing:

The student shall be declared pass if he gets minimum 50% marks each in theory and in practical/Clinical including viva-voce examination.

A criterion for passing is mentioned only as guidelines to the examiners for the assessment of different heads. Since, the result is given in the form of 'Pass' or 'Fail' to the University, these marks will be kept as record.

Rules of A.T.K.T:

- 1) Student failing in one or more subjects in M.D. (Hom.) Part-I examination will have to appear in the subsequent university examinations for the subjects in which he has failed but only one chance to reappear in that subject.
- 2) Student shall be eligible for admission to M.D. (Hom.) Part-II course only if he passes in all the subjects at M.D. (Hom.) Part-I examination.

Standard of Passing:

Examination Guidelines:

A candidate who appears at First BHMS examination, Second BHMS examination, Third BHMS examination or Fourth BHMS examination but fails to pass in the subject or subjects shall be re-admitted to the next examination in the subject or subjects (theory and practical including oral wherein he has failed).

If a candidate fails to pass in all the subjects with in four chances in examinations, he shall be required to prosecute a further course of studying all the subjects and in all parts for one year to the satisfaction of the head of the college and appearing for examination in all the subjects.

Provided that if a student appearing for the Fourth BHMS examination has only one subject to pass at the end of prescribed chances, he shall be allowed to appear at the next examination in that particular subject an shall complete the examination with this special chance.

Candidates who have passed in one or more subjects need not appear in that subject or those subjects again in the subsequent examinations if the candidate passes the whole examination with in four chances including the original examination.

There shall be a regular examination and a supplementary examination in a year and the supplementary examination shall be conducted within two months of declaration of results (including issue of mark sheets);

For non-appearance in an examination for any reason, a candidate shall not have any liberty for availing additional chance to appear in that examination.

Grace Marks:

The University of examining authority shall have the discretion to award grace marks at the maximum to ten marks in total if a student fails in one or more subjects.

Rules of ATKT:

The candidate must pass the First BHMS examination in all the subjects at least one term (6 months) before he is allowed to appear in the Second BHMS examination provided that he has passed in the subjects of Anatomy and Physiology (including Biochemistry) examinations two terms (12 months) before he is allowed to appear in the Second BHMS examination.

- a) No candidate shall be admitted to the Second-BHMS examination unless he has passed the First BHMS examination.
- b) No candidate shall be admitted to the Third-BHMS examination unless he has passed the Second BHMS examination.
- c) No candidate shall be admitted to the Fourth-BHMS examination unless he has passed the Third-BHMS examination.

The candidate must pass the Second BHMS examination at least one term (6 months) before he is allowed to appear in the Third BHMS examination.

The candidate must pass the Third BHMS examination at least one term (6 months) before he is allowed to appear in the Fourth BHMS examination.



NOTIFICATION 612

Sub: Supplementary examination for Pharm.D. programme - regarding

The Regulation 10 of Pharm. D. Regulations 2008 provides for conduct of supplementary examinations. Regulation 15 of the Pharm. D. Regulations 2008 provides that students who have appeared for all the subjects and passed the first year annual examination are eligible for promotion to the second year and, so on. However, failure in more than two subjects shall debar him or her from promotion to the next higher classes.

The Pharmacy Council of India at its 89th Central Council meeting held in April, 2012, further clarified these two Regulations as follows -

"If the failed students of annual examination passed in the supplementary examination, they are eligible for promotion to the next higher class without losing additional six months."

Considering the above Regulations and the clarifications provided by the Pharmacy Council of India, it is hereby notified that -

- 1. Every year there shall be two examinations for Pharm.D. programme. The First examination in a year shall be the annual examination and the second examination shall be supplementary examination.
- The supplementary examination shall be conducted within 45 days from the date of declaration of the result of the annual examination.
- Based on the results of the supplementary examination, if the candidates become eligible for promotion to the higher class they may be promoted to the next higher class. However, failure in more than 2 subjects shall debar the students from promotion to the next higher classes.
- Those students who are eligible to be promoted to the next higher class will join the higher class immediately.

This notification will be implemented with immediate effect and the first supplementary examination shall be held by August 2012.





 - A student will be eligible for only one certification. Once a certification is awarded to the student, he/she will not be eligible to be awarded higher certifications. However the student will be eligible for mark sheets of the higher certifications.



A student who fails at UE in a course has to reappear only at UE as a backlog candidate and clear the head of passing. Similarly, a student who fails in a course at IA has to reappear only at IA as a backlog candidate and clear the head of passing.

The performances at UE and IA will be combined to obtain the Grade Point Average (GPA) for the course. The weights for performance at UE and IA shall respectively be 60% and 40%.

GPA is calculated by adding the UE marks out of 60 and IA marks out of 40. The total marks out of 100 are converted to grade point, which will be the GPA

Formula to calculate Grade Points (GP)

Suppose that 'Max' is the maximum marks assigned for an examination or evaluation based on which GP will be computed. In order to determine the GP, Set x = Max / 10 (since we have adapted 10-point system). Then GP is calculated by the formulas shown as below.

Two kinds of performance indicators, namely, the Trimester Grade Point Average (TGPA) and the Cumulative Grade Point Average (CGPA) shall be computed at the end of each term. The TGPA measures the cumulative performance of a learner in all the courses in a particular Trimester, while the CGPA measures the cumulative performance in all courses since his/her enrolment. The CGPA of learner when he/she completes the programme is the final result of the learner.



Appointment of Paper Setters and Examiners

REGULATION NO.: EXAM-3

A. Applications for Examinerships:

Applications for Examinership can be made to the Registrar/Controller of Examinations in the prescribed form before the end of August every year. They will be placed before the respective Boards of Studies for consideration. The prescribed application form can be obtained from the University Office on gratis.

B. Panels of Examiners:

The Board of Studies shall prepare the panels of persons to be appointed as examiners of each subject within its jurisdiction and update the same every year for submission to the Committee, mentioned in C.

C. Appointment of Papersetters and Examiners (including Theory and Practical):

The Papersetters and Examiners will be appointed by a committee consisting of the following members. The Committee will select the names for these appointments from the panels prepared by Board of Studies:

- 1. Vice-Chancellor (Ex- Officio Chairman)
- 2. Pro Vice-Chancellor
- Dean of concerned faculty
- 4. Chairman of concerned Board of Studies
- Controller of Examination (Ex-Officio -Secretary)

The lists of Papersetters and Examiners will have to be got approved by the Academic Council or by the V.C. on behalf of A.C.

D. Assessment of Answer Books:

The assessment of answer books will be done through a centrally organised assessment programme (CAP). The Controller of Examination will prepare the time table of the CAP for various examinations and will organise CAP's as per the schemes prepared and approved for the same.

Scheme of Central Assessment Programme

REGULATION NO. EXAM - 4

The Scheme of Central Assessment Programme

- 1) The CAP's will be organised in as many constituent colleges/institutes as necessary.
- The Principal/Director of the College/Institute where the CAP is to be conducted will act as a Director of the CAP. The Principal/Director may also recommend the name of Senior Teacher to act as the Director of CAP in his place.
- 3) As far as possible the CAP for medical course examination will be organized on the days of their practical examinations. This is to enable the examiners of the theory paper to participate in the practical examinations.
- 4) The Director of CAP shall send invitation letters to the examiners for the CAP as per the list provided by the University well in advance.
- 5) The Director may make substitute/ additional appointments if necessary in consultation with the Controller of Examination.
- The University shall provide information about number of students appearing for each subject and other relevant matters to the Director to enable him to make adequate and proper arrangements for the CAP.

Collection of necessary answer books

- It is the responsibility of the Principal/Director to see that all the answer books of the examination held at his centre reach the venue of the CAP in time. The necessary instructions in this regard will be given to him by the University.
- After the answer books are received at the CAP centre the staff employed for the administration of the CAP shall perform the following duties.
 - a) They will check up answer books in each bundle to see whether they are as per Junior Supervisors report. If they find any discrepancies the same should be immediately informed to the Controller of Examinations.
 - b) They shall verify whether they have received all the answer books of different subjects from the concerned centres of examination.
 - They will complete the process of masking the seat numbers on the answer books. They should see that every answer books is masked. They will prepare the bundles of answer books containing 30-40 answer books in each bundle.
 - On the day of commencement of the CAP the Director will give information about the programme of the CAP, seating arrangements etc.
 - e) The Chairman of Board of Paper Setters and Examiners or in his absence a Senior Examiner nominated by the Director of the CAP shall convene a meeting of the examiners to discuss the question papers, scheme of marking etc. with a view to attain uniformity and consistency in assessment.
- He shall monitor the progress of the assessment daily and assist the Director in the smooth conduct of CAP.
- On the last day of the CAP the Chairman shall submit a consolidated report on the performance of the candidates in each subject.

- h) The programme of the CAP should be so arranged that no examiner should be required to examine more than 45 answer books every day.
- i) The minimum number of answer books to be examined by the examiner shall be 30.
- j) The signatures of the concerned examiners should be taken by the examiner while giving the answer books to them for assessment and while taking the assessed answer books back.
- After assessment all the answer books of a particular subject or examinations is over the staff at the CAP centre will unmask the answer books and check them to see whether any question is left unassessed.

They will then prepare the mark list. While preparing mark list they will record marks on the answer books. They will also carefully record the seat numbers of absent candidates from the Junior Supervisor's report on the mark list. They will make the totals and check them on the marks obtained by the candidate. Entries on each page of the mark list will be countered checked by the other assistants.

- The assessed answer books then shall be rearranged as per their seat numbers and should be put in bundles along with absentee reports.
- m) The Director of the CAP will sent the mark list with corresponding answer books and Junior Supervisor's report to the University.

Administrative Expenses of CAP

The Director of the CAP will be paid an amount for execution of CAP at the rate of Rs.10/- per candidate.

The Director of the CAP will ordinarily appoint the staff of his own confidence as per general norms mentioned below :

- i) One Assistant Director, two clerks and three peons :
- ii) Rate of Remuneration to be paid to Administrative Staff

a)	One Director	Rs.175/- per day
b)	Asstt. Director	Rs. 125/- per day
c)	Clerk	Rs.60/- per day
d)	Peon and Watchman	Rs.40/- per day

The payment of Local Conveyance Allowance, Travelling Allowance and Daily Allowance and remuneration shall be made to the examiners appointed for assessment of answer books from the advance placed at the disposal of the Director. This payment shall be made according to the rules prescribed by the University. Accounts of the Central Assessment Programme shall be got audited from the Internal Auditor and submitted to the University Office within one month from the date of conclusion of CAP.

No. 5
Verification and Revaluation of
Answer Books

REGULATION NO.: EXAM - 5

VERIFICATION AND REVALUATION OF ANSWER BOOKS

- The candidate who has appeared at the University examination may apply to the Controller of Examinations in the prescribed form for verification of marks of his theory papers through the Principal of his/her college.
- A candidate shall submit an application only in the prescribed form to the Controller of Examinations for:
 - Verification along with fee of Rs.50/- per head of passing AND
 - Revaluation of answer books of theory paper/s along with fee at the rate of Rs.100/per theory paper for nonprofessional courses and Rs.200/- per theory paper for
 professional courses in addition to the fee for verification of marks.
- The candidate should submit his application form for verification of marks and revaluation of answer books within 15 days from the date of result, through the Principal/Head of his Colleges/Institution.

No application for verification and or revaluation will be entertained unless:

- A xerox copy of the statement of marks at the examination concerned is enclosed to the application.
- Seat No., nomenclature of theory paper/s date of examination and examination centre are correctly mentioned.
- iii) Exact amount of fee as prescribed in the rule is remitted along with the application form.

This fee shall not be refunded if the applicant's application is processed for revaluation. However, the fee for revaluation is liable to be refunded in case, the application is not entertained and not processed for revaluation under the provision of this Regulation.

 iv) If it is not received within 15 days from the date of declaration of concerned examination result.

A student who has appeared at the University examination can apply for revaluation of his/her answer books of the theory papers of the University Examination subject to the following conditions :

- A student can apply for revaluation in maximum 50% of heads of passing in theory subject/s or maximum three heads of passing in theory subject/s whichever is less at the University examination for which he/she has appeared. However, a candidate who has appeared for 1st MBBS examination may apply for revaluation in maximum two theory papers at any attempt.
- The revaluation includes verification also. If on verification of marks it is found that the marks originally shown in the mark list issued to a candidate have changed, either minus or plus as a result of verification the changed marks shall be considered as original marks for the purpose of revaluation.
- The revaluation of the answer books however shall not be permitted in respect of scripts of Practical examination/Term Work/Internal Assessment/Sessional Marks/Dissertation/Thesis/Clinical/ MCQ (Multiple Choice question in practical examination) and Viva-Voce examination.

- 4. The Principals of the concerned Colleges/Institutes shall collect all the application forms for verification of marks/revaluation of answer books along with prescribed fee from the students and send the same to the University in one lot with a demand draft of the amount of verification / revaluation of fees collected.
- The result of the revaluation of applicant's answer books of the theory paper/s shall be binding on him and that he shall accept the revised marks allotted to his theory paper/s after revaluation.
- 6. The benefit of revaluation shall be given to a candidate if the marks obtained by the candidate after revaluation exceed his original marks by at least 10% or more of the maximum of marks allotted tp each theory paper. Only these marks will be accepted by the University and will have to be accepted by the student. For the purpose of computing the 10% difference in marks, half percent of the marks assigned to the paper or a part thereof shall be taken into account and rounded off for next successive higher integer.
- 7. The revised marks obtained by the student after revaluation and as accepted by the University shall be taken into for the purpose of amendment of his/her result in accordance with the rules of the University made in that behalf.
- 8. For the purpose of this rule, revaluation of the answer books of the theory paper/s shall be considered as an additional facility provided to the students with a view to improve upon their results at the preceding University examination. It is being understood that delay in the declaration of revaluation result for any reason whatever, shall not confer any right upon the concerned to claim for admission to the next higher class. Such a matter shall always be regulated in accordance with the relevant rules or regulations framed by the University in that behalf.

If because of changed result the candidate attracts the provision of condonation of deficiency the same shall be applied in his case.

9. Mode of revaluation:

The answer book shall be re-examined by a different examiner of the choice of the Vice Chancellor.

10. Though there is no revaluation for Term-end Examination, a student may make an appeal to the Vice Chancellor to look into his grievance if any. The Vice Chancellor if convinced may take necessary step to redress his grievance.



Disciplinary Action in Case of Use of Unfair means by the Students

Disciplinary Action Against Staff Members involved in Lapses in the University Examination

REGULATION NO. 6

DISCIPLINARY ACTION IN CASE OF USE OF UNFAIR MEANS BY THE STUDENTS & DISCIPLINARY ACTION AGAINST STAFF MEMBERS INVOLVED IN LAPSES IN THE UNIVERSITY EXAMINATION PART - A

It is hereby noticed for information of all concerned that the following shall be the procedure of disciplinary action in case of use of unfairmeans by the students in the University Examination.

 Competent Authority - The Board of Management and Vice Chancellor of the University shall be competent authorities to take appropriate action against the student/s using, attempting aiding, abotring, instigating or allowing to use unfairmeans at the Examinations of the University.

Definition: Unless the context otherwise requires.

- a) "Student" means and includes any person who is enrolled as a candidate for any examination of the University.
- b) "Unfair means" includes one or more of the following acts, omission or commissions on the part of student/s during the examination time.
- i) Possessing unfairmeans material
- ii) Transcribing any authorised material or any other use thereof.
- iii) Intimidating or threatening use of violence against invigilator or person on duty in the examination hall of man handling him/her or leaving the examination hall without permission of the supervisor.
- Leaving the examination hall with answer books and/or supplement or any part thereof either written or blank.
- Unauthorisedly communicating with other examinees and or anyone else inside or outside the examination hall.
- vi) Making any marking or sign on the answer book which may reveal the examinee's identity to the examiner.
- vii) Causing disturbances in any manner in the examination proceedings.
- viii) Persuading, instigating, coercing students to leave or to walk out of the examination hall or to do anything that would disturb the working of examination.
- ix) Or any other similar act of omission or commission which may be considered as unfairmeans by the Competent Authority.
- c) "Unfairmeans relating to examination" means and includes directly or indirectly committing or threatening to commit any act of coercion, undueinfluence or fraud with a view to obtain wrongful gain to him or to any other person or causing wrongful loss to other person/s.
- d) "Unfairmeans material" means and include any material whatsoever, related to the subject of the examination, printed, typed, written or otherwise on the person of the examinee or on wood or other material in any manner or in the form of a chart, diagram, map or drawing etc. which is not allowed in the examination hall.
- e) "Possession of unfairmeans material by a student" means having any unauthorised material on his person or desk or chair or table or at any place within his reach, in the examination centre and its environs or premises at any time from the commencement of examination till its conclusion.

- f) "Student found in possession" means a student, reported in writing as having been found in possession of unfairmeans material, by Junior Supervisor, Senior Supervisor, member of the vigilance committee or any other person authorised for the purpose, in this behalf, even if the unfairmeans material is not produced a evidence because of its being reported as swallowed or destroyed or snatched away or otherwise taken away or spoiled by the student or by any other person acting on his behalf to such an extent, that it has become illegible. Provided report to that effect is submitted by the Senior Supervisor to the Registrar or an Officer authorised in this behalf.
- g) "Material related to the subject of examination" means and include, if the material to produced as evidence, any material certified as related to the subject of the examination by a competent person and if the material is not produced a evidence or has become illegible for any of the reasons referred to in clause (f) above, the presumption shall be that the material did relate to the subject of the examination.
- h) "Senior Supervisor" means and includes Principal of the College concerned/head of the Institution concerned, where concerned examination is being conducted and any other person duly authorised by him or a person appointed as in-charge of Examination by the authority competent to appoint to such.
- During Examination, Examiners and other students shall be under disciplinary control of the Senior Supervisor/s.
- 3. Senior Supervisor/s of the Examination centre shall in the case of unfairmeans, follows the procedure as under :
 - The Examinee shall be called upon to surrender to the Senior Supervisor, unfairmeans material found in his or her possession, if any and his/her Answer Book and
- II. Signature of the concerned student shall be obtained on the relevant papers and on the list thereon, concerned Junior Supervisor and Senior Supervisor shall sign all the relevant documents.
 - III. Statement of the examinee and of the concerned Junior Supervisor shall be recorded in writing by the Senior Supervisor. If the student refuses to sign any such material or refuses to make statement, Senior Supervisor shall record accordingly, under his signature.
 - IV. Senior Supervisor shall take one of the following decisions depending upon seriousness / gravity of the case.
 - Expell the concerned student from the Examination and not allow him to appear for remaining Examination.

OR

- Expell the concerned student from the Examination and not allow him to complete the paper/practical etc. as the case may be during course of which he was caught.
- Confiscate his answer books, mark it as "suspected answer-books" and issue him fresh answer book duly marked.
- V. All the material and list of material mentioned in sub-clause (I) and the statement of the examinee and that of the Junior Supervisor as mentioned in and the answer books shall be forwarded by the Senior Supervisor along with his report to the Registrar in a separate and confidential sealed envelope marked "suspected unfairmeans".
- VI. In case of unfairmeans of oral type the Junior and Senior Supervisor or concerned authorised person shall record the fact in writing and shall report the same to the Registrar of the University.

PROCEDURE TO BE FOLLOWED BY EXAMINER DURING ASSESSMENT:

- 4. If the examiner at the time of assessment of answer-books suspects, that there is a primafacie evidence that the examinees whose answer book/s he is assessing appears to have resorted to unfairmeans in the Examination he shall forward his report along with the evidence to the Registrar with his opinion in separate confidential sealed envelopes, marked "suspected unfairmeans".
- 5. Cases of Unfairmeans reported to the Registrar by the Senior Supervisor/s and or Examiners shall be inquired into by the V.C. or Committee / appointed by B.O.M. The cases of unfairmeans reported through any other source shall be scrutinized by the Registrar and if he is satisfied that there is prima-facie case the same shall be placed before the V.C. for decision.
- 6. Result/s of the examination of concerned student/s involved in such cases may be held in reserve till the competent authority taken final decision in the matter.
- 7. The V.C. may appoint committee to hold inquiry regarding cases of unfairmeans.
- 8. The B.O.M. or the V.C. may impose any one or more of the following punishment/s on the student/s found guilty of using unfairmeans.
 - i) Cancellation of the performance of the examinee in that examination/s.
 - ii) Debarring student/s from appearing for any examination/s of the University for stipulated period not more than 5 years or
 - Debarring student/s from taking admission for any course in the University/College/Institution for the stipulated period of not more than 5 years.
 - iv) Cancellation of University scholarship/s award/s prize/s etc. awarded to him by the University for his performance in the concerned examination.
- 9. The procedure laid down in clause no.9 may not be followed and all or nay of its provisions may be waived in the following circumstances:
 - When the order of punishment is to be on facts which have led to the conviction of the student charged in criminal court.
 - When the student has abscounded on for any other reason and it is not possible to contact the student.

PART-B

Rules regarding disciplinary action against the persons involved in malpractices in the University examinations - $\,$

- Board of Management of the University shall be the competent authority to take disciplinary
 action against paper setters/examiners/invigilators or other teaching and non-teaching
 employees of the employees of the University/constituent college/institution to whom the
 examination work has been assigned and who have been found involved in acts of
 malpractices related to examination.
- 2. For the purpose of this rule the act of malpractice means and includes -
 - Disclosing of the contents of question paper or its manuscript in any manner except in accordance with the instructions given by the competent authority / persons for consideration or otherwise.
 - Supply of answers fully or partly to the questions set in the question papers during or before the examinations to the examinee.
 - Performing the assigned examination duty in negligent manner or not taking reasonable care in its performance such as not submitting the assessed answer books with the prescribed time etc.

- Assessment of the answer books of the examinee for any consideration other than merit.
- v) Use of any other unfair means.
- 3. The following punishment/s may be imposed on those who are proved to be guilty.
 - a) Debarring the person/s from participating in any manner in the University Examination for a stipulated time.
 - b) Forfeiture of the amount of remuneration of the Examination work to be paid to the concerned part or full.
 - c) Fine not exceeding the amount of remuneration.
- 4. Procedure for imposing penalty -
 - Due notice shall be given to the concerned person about his alleged act of malpractice use of unfairmeans.
 - ii) Person so charged shall be required to submit his/her written representation within 15 days of the receipt of the notice.
 - iii) If she/he fails to submit her/his written say within the time stipulated above, the enquiry authority may proceed with the enquiry ex-parte.
 - iv) If the person requests for an opportunity for making any oral statements in addition to any written representation submitted by him and if the Enquiry Authority deems it necessary the opportunity of oral hearing may be given to him/her.

No. 7 Grace Marks and Condonation

REGULATION EXAM. NO. 7 RULES REGARDING GRACE MARKS AND CONDONATION

Grace Marks for getting Distinction

A candidate who has passed in all the subjects/Heads of passing in an examination can be given up to three marks in grace in subject/s if so required to get him distinction in the concerned subject/s.

Grace marks only for passing

The examinee shall be given grace marks if required only for passing in head/s of i) passing (Theory/Practical/Oral) as shown below:

Note - Grace marks given in the head of passing under the Regulation will be added in the marks obtained and accordingly should be reflected in Examination Result ledger and statement of marks.

Grace marks for getting higher class ii)

A candidate who has passed in all the subjects and heads of passing in the examination and whose total number are less than those required for getting Second Class or Higher Second Class (55%marks) or First Class with Distinction or any (next) final grade by 1% of the aggregate marks of that examination or up to 10 marks whichever is less shall be given the same to get the next higher class/grade.

Provided that benefit of above mentioned grace marks shall be given to the candidate for such examination/s only for which provision for award of class has been prescribed.

iii) Condonation

If a candidate has passed in all other heads of passing but has failed in one head of passing, his deficiency of marks in such a head of passing may be condoned by not more than 1% of the aggregate marks of the examination or 10% of the total number of marks of the head of passing in which he is failing, whichever is less.

iv) Condodation on the basis of Higher Marks

If a candidate has passed in all other heads of passing in the examination but has failed in only one head of passing, his deficiency of marks in that head of passing may be condoned as follows:-

- a) Up to 10% of the total number of marks of the concerned Head of passing if the percentage of marks obtained by the candidate in all the subjects/courses taken together exceeds by 10% over minimum percentage of marks required for passing.
- b) Up to 15% of the total number of the concerned head of passing if the percentage of marks obtained by the candidate in all the subjects/courses taken together exceeds by 15% over minimum percentage of marks required for passing.

Illustration

If the total number of marks required for passing in all the subjects/courses taken together comes to 40% of aggregate marks the total number of marks obtained by the candidate in all the subjects/courses taken together should be at least 50% of the aggregate marks for application of the Regulation 8(a) and 55% of the aggregate marks for application No. 8(b).

5. While giving benefit of any of the Regulation to the candidate at any examination for condonation of failure in any of the head of passing and or for awarding next higher class grade if any difficulty arises, the Vice-Chancellor in consultation with the Dean of the concerned Faculty shall take decision in the matter which shall not be inconsistent with the objects of these Regulations and his decision shall be final.

While giving benefit of any of the Regulation for condonation of deficiency in failure of any of head of passing or awarding next higher class only such marks may be awarded as are required for passing.


Those marks shall not be divided for condonation of more than one head of passing.

6. No candidate shall be entitled for the benefit of gracing or condonation permissible under more than one regulation except regulation No.5 and regulation No.11 respectively i.e. the benefit of regulation No.5 and regulation related to extra marks for extracurricular activities can be granted to any candidate at one examination, the benefit of other two Regulations shall not be granted to any candidate at one examination.

Notes for Regulations

- i. If a candidate fails in a head of passing, which is included in another head of passing, of the same subject, he shall be entitled to the benefit of the condonation in both the heads, if necessary, subject to the maximum limit of condonation permissible for each head in accordance with the above paragraph.
- ii. If a deficiency of marks is condoned, the class/grade in the concerned examination of the candidate, shall be declared on the actual marks obtained by the candidate.
- iii. The benefit of not more than one Regulation shall only be given for one examination of one course.
- iv. The benefits under above mentioned Regulation shall not be available for internal assessment.
- v. The benefits of above mentioned Regulation may be given to the candidates appearing in the examination with backlog and / or exemption whenever such an exemption / system of backlog has been provided.
- vi. The benefit under above mentioned Regulation shall be given at the time of declaration of final examination only.
- vii. Final examination for the purposes of this Regulation means and includes such examination/s on the basis of marks of which class/grade is awarded.

No. 8

Grant of Additional Marks for Extra Curricular Activities

REGULATION EXAM. NO. 8

Rules regarding additional marks for Extra Curricular Activities

- 1.(A). Notwithstanding anything contained in any other Ordinance, five/ten additional marks may be granted to candidate appearing for University examination, as an incentive, for his participation in any one or more of the following activities:
 - a) National Cadet Corps
 - b) National Service Scheme
 - c) Inter-University, National/International Sports
 Tournament/Debating/Elocution/Dramatics/Moot Court and such other
 competitions as approved by the Board of Management from time to time.
 - d) National Physical efficiency drive
 - e) Literacy Programme of the University.
- 1.(B). The candidate at individual event or in team event securing Gold/Silver/Bronze Medal in the Sports at National Level or All India Level shall be granted five marks.
- 1.(C). The candidate who has enrolled his/her name in NSS and completed 240 hours under Regular Activities will get five marks and candidate who has completed one special camp of ten days duration. No additional marks will be granted separately for completion of N.S.S. Special Camp.
- 2. The additional marks shall be added:-
 - (a) to any head/s of passing or to any subject/s as case may be, in the examination if the student has failed in such head/s of passing subject/s and if such additional marks enable the student to get necessary passing marks OR
 - (b) to any subject if such additional marks enable the students to get benefits exemption. Such additional marks only as are required for examination, shall be given.
 - (c) If the candidate has failed in more than one head of passing/subject the additional marks shall be added to the head of passing or to the subject where the student has scored the highest marks amongst the failing heads of passing/subjects.

If after the grant of additional marks under clauses (a) and (b) above, if there is any balance of marks, it shall be added to the total number of marks of the examination.

OR

- (d) to the total number of marks secured by the candidate in the examination. Provided that the additional marks shall not be taken into consideration for the purpose of award of prize, scholarship, merit list or for such other similar purposes.
- The additional marks shall be granted to the candidates only for the examination during the course of which the candidate has participated in the activities mentioned in clause no.1.

Provided that repeater candidate shall be eligible to get the benefit of such additional marks for the same examination only once, but not beyond three years from first appearance.

Note: The candidate shall be eligible to get maximum 5/10 additional marks whichever is applicable only once for any of the activities mentioned above, if performed by him in any year, and only for an examination of one course.

Illustration: Candidate has taken admission for LL.B. and Diploma in Taxation Laws courses. Simultaneously in the year 1987 he has participated in the Inter University Elocution Competition in the year 1987. Such a candidate shall be eligible to benefits of the five marks on the basis of such Elocution Competition either for the examination of LL.B. course or for Diploma in Taxation Laws for he has taken admission in 1987.

- The additional marks shall be granted to the candidate subject to the conditions mentioned hereunder:
 - a) NCC: Candidate enrolled in NCC must have passed 'B' and 'C' or certificate examination and candidate enrolled in NCC must have attended 75% parades out of total number of parades and one camp prescribed for NCC.
 - NSS: Candidates enrolled in NSS must have completed 240 hours under Regular Activities and attended on special camp of ten days duration, as required under NSS programme.
 - c) National Physical Efficiency Drive : Candidate enrolled in National Physical Efficiency Drive must have acquired three stars under the programme.
 - d) Inter University Tournaments/Competitions: Candidate must have participated in the Inter University Tournament/Competitions as a Representative of this University or candidate must have participated as a representative of State of Maharashtra/India.
 - Literacy Programme: A candidate must have completed at least 200 clock hours work to the satisfaction of the Project-in-Charge and Principal and secured necessary certificate.
- 4. A candidate shall submit an application before the date of commencement of his examination along with fee of Rs.10/- for the grant of additional marks along with necessary original certificate or copies thereof countersigned by the Principal of the College/Head of the recognized Institution/Department. No application received after the commencement of examination shall be entertained by the University.
- If any difficulty arises in giving effect to provisions of this ordinance, the Vice-Chancellor may in consultation with the Dean of the Faculty concerned give his decision in such a particular case. The decision of the Vice-Chancellor shall be final and binding in such



Rules regarding additional marks for Extra Curricular Activities

These rules shall be called "Revised Rules regarding Additional Marks for Extra Curricular Activities". These rules are effective from 21st October, 2011, the date of approval of the same by the Board of Management.

Notwithstanding anything contained in any other Ordinance, additional marks shall be granted to candidate appearing for University examination, as an incentive, for his / her participation in any one or more of the following activities as per the norms of the Government/University as the case may be:-

- a) National Service Scheme
- b) Inter-University, National / International Sports Tournament / Debating / Elocution /Dramatics / Moot Court and such other competitions as approved by the Board of Management from time to time.
- c) National Cadet Corps
- d) National Physical efficiency drive
- e) Literacy programme of the University

National Service Scheme :-

The State Government through its resolution No. Sankirn-2010 / (125/2010)/ss-7 dated 29/12/2010 of the Higher and Technical Education Department, has directed the Universities that the NSS students who have put in 240 hours of work for 2 years (120 hours each year) and have participated in a seven days residential NSS camp in adopted villages shall be given 10 additional marks in the final examination soon after completion of the above requirement.

The additional marks shall be added

a) To any head/s of passing or to any subject/s as case may be, in the examination if the student has failed in such head/s of passing subject/s and if such additional marks enable the student to get necessary passing marks

OR

b) If the candidate has failed in more than one head of passing / subject the additional marks shall be added to the head of passing or to the subject where the student has scored the highest marks amongst the failing heads of passing, subject to the condition that such addition of the marks helps the candidate to pass the examination in that subject

OR

c) In case if the additional marks does not result in passing in any subject, such marks shall be carried forward and the candidate can claim the

benefit of such marks in the subsequent examination of the same course within a period of three years from his first appearance in such examination.

- d) If the candidate has passed in all subject/s the additional marks shall be added in the subject / paper where he has obtained least marks. Provided that the additional marks shall not be taken into consideration for the purpose of award of prize, scholarship, merit list or for such other similar purposes.
- e) In order to take benefit of the additional marks for NSS activities the candidate shall fulfill the conditions laid down by the Govt. of Maharashtra as stated above.
- The marks cannot be split.

2 Extra Curricular Activities approved by the Board of Management other than NSS:-

A candidate who has participated in any of the activities / programmes approved by the BOM such as at Inter University / National / International sports tournaments / debating / elocution / dramatics / literacy programme shall be given the benefit of additional 05 marks each for every activity , subject to the conditions .

- i) The benefit can be extended only for the examination/s during the course of which the candidate has participated in the activities mentioned above.
- ii) The candidate can claim every year maximum benefit of 05 marks irrespective of the number of activities he has participated.
- iii) The candidate cannot avail the benefit of 5 marks for extra curricular activities during a year, in which he has claimed the benefit of 10 additional marks for NSS activities.

The additional marks shall be granted in case of

- i) Inter University Tournaments / Competitions: Candidate must have participated in the Inter University Tournament / Competitions as a Representative of this university or candidate must have participated as a representative of State of Maharashtra / India.
- ii) NCC: Candidate enrolled in NCC must have passed 'B' and / or 'C' certificate examination and candidate enrolled in NCC must have attended 75% parades out of total number of parades and one camp prescribed for NCC to become eligible for the additional 5 marks.
 - National Physical Efficiency Drive: Candidate enrolled in national physical efficiency drive must have acquired three stars under the programme.



- iv) Literacy Programme: A candidate must have completed at least 200 clock hours work to the satisfaction of the Project-in-Charge and Principal and secured necessary certificate.
- A candidate shall submit an application before the date of commencement of his examination for the grant of additional marks along with necessary original certificate or copies thereof countersigned by the Principal of the College / head of the recognized Institution / Department. No application received after the commencement of examination shall be entertained by the University.
- These rules shall not be applicable to those faculties / courses where granting of additional marks is prohibited by the respective councils.
- The Inter-University / National / International Sports Tournament / Debating/ Elocution/Dramatics/Moot Court and such other extra curricular activities shall be approved by the Board of Management from time to time. The list of such activities shall be supplied to the Controller of Examinations much in advance before commencement of examinations. The candidate can claim benefit of additional marks only for such activities which are approved by the Board of Management and listed with the Controller of Examinations.
- 6 If any difficulty arises in giving effect to provisions of this ordinance, the Vice-Chancellor may in consultation with the Dean of the faculty concerned give his decision in such a particular case. The decision of the Vice-Chancellor shall be final and binding in such matters.





Flying / Vigilance Squad

REGULATION EXAM. NO.9 FLYING VIGILANCE SOAD

- Flying/Vigilance squads may be appointed by the Vice Chancellor to visit the centres of University Examinations,
 - To ensure that the University Examinations are conducted as per norms laid down.
 - To check whether the Senior Supervisors and Block Supervisor and other staff doing Examination work are following the instructions scrupulously.
 - iii. To see whether the students are involved in mal-practices at the time of University Examinations and report such cases to the University.
- 2. The flying vigilance squads are authorised to visit any centre of University Examinations without prior intimation to the office of Senior Supervisor and enter into any block of examination for checking the candidates identity card, fee receipts, hall tickets etc. to ascertain the candidates identity. The flying/vigilance squad is invested with the necessary authority to take any action for detecting and checking malpractices and use of unfairmeans in the University Examination.
- The Senior Teachers of Colleges/Institutions can be the members of the Flying/Vigilance squad.
- The Flying/Vigilance squads will send their report of their surprise visits directly to the Vice Chancellor. The Flying/Vigilance squad can make suggestions in the matter of proper conduct of examinations, if necessary.


Regulation Exam. No. 10

Rules regarding the Benefit of better performance

- 1) If an examinee appears for the subject / head of passing of the same examination of the University for more than once highest mark obtained by him / her in the last two previous examination shall be considered for the result of the concerned examination on the following conditions:
 - i) If an examinee submits an application for the purpose along with copies of the statement of marks of the concerned examination attested by the Principal of the college, Head of the University Department, with a fee of Rs. 100/- within a period of 45 clear days from the day of declaration of his result.
 - ii) If due to such marks of previous attempt examinee passes the subject concerned and also examination as a whole.
 - iii) If an examinee has not failed in more than one subject / head of passing
- 2) In case of change of marks due to the benefit of better performance the date of the revised statement of marks shall be the date, on which the benefit of performance is given as per the above clause 1
- 3) If an examinee does not appear is any subject of passing in which he / she failed in the previous attempt his / her performance is such subject / head of passing shall be treated as nil, unless he / she claims the benefits provided ir. Clause No. 1
- 4) The clause I Shall not be applicable to:
 - All examinations for which passing in all the subjects is required at the one and the same attempt.
 - ii) All the examinations in Medical Faculty.
 - iii) If Examinee remains absent for the subject / head of passing of the examinations.
- 5) If an examinee passes in any one or more subject / s, head / s of passing, of any examination he shall not be allowed to appear for subject / s, head / s unless there is specific provision to that effect in respect of concerned examination.

Rules for supply of certified photocopy of answer-books

These rules shall be called "Rules for Supply of Certified Photocopy of Answer Books 2011". These rules are effective from 21st October, 2011 the date of approval of the same by the Board of management.

- An examinee candidate can make an application in the prescribed format for the supply of certified photocopy of the evaluated theory answer book in any of the theory paper/s of the course for which he/she has appeared in the preceding university examination.
- 2. The duly filled in application form along with the photocopy of the marksheet of the preceding examination shall be submitted to the Controller of Examinations through the Principal / Director of the constituent unit within ten days from the date of declaration of his/her results alongwith a demand draft for Rs. 300/- (Rupees three hundred only) per paper towards the fees for supply of the certified photocopy of the answer book. In respect of those candidates who have applied for verification of marks and revaluation of the answer sheet, the ten days time limit commence from the date of declaration of the result consequent on the revaluation.
- The Demand Draft shall be drawn in the name of Registrar, Bharati Vidyapeeth
 Deemed University, Pune. The fees once paid is non-refundable. The
 examinee shall obtain written acknowledgement from the Principal / Director
 for the application he/she has submitted.
- On receipt of the application form, the Principal / Director shall submit the list
 of the students who have applied for supply of certified copy/ies of theory

1. The candidate who has passed UG & PG degree examinations of this university with class mentioned in column no. 1 and who desires to improve the class as shown in column no. 2 below will be permitted at his/her option to appear for the same examination without being required to keep any terms.

- 2. For improvement of class the candidate will be required to apply and allowed to appear only for theory examinations.
- 3. A candidate shall have to reappear for minimum 1/3 and / or maximum of all the theory papers at a time on which the class is awarded. Candidate should ensure that the examination time table for the subjects he is appearing will not clash.
- 4. Performance of the candidates appearing for the subjects less than 1/3 of the total theory examinations mentioned above will not be considered. However, his appearance will be counted as an attempt.
- 5. If the candidate who has reappeared for the final year examination under the provisions of this notification for improving his / her class, is successful in improving his / her class by such reappearance, he/she will have to surrender to the university the original degree and the statement of marks that he / she had obtained in that course/subject. Unless original degree and the statement of marks

are returned to the university by the candidate, the new degree certificate and statement of marks cannot be issued to the candidate. In the revised degree certificate / statement of marks to be given to the candidate a mention will be made of the fact that he / she improved his / her class under Improvement attempt.

- A candidate appearing for the improvement of class/grade shall not be entitled to get benefit of any other rules/orders of the university regarding condonation/grace marks.
- Candidate appearing for the improvement of class/grade shall not be entitled to get any prize/medal/scholarship/award etc.
- A candidate who has re-appeared for the above examination/s under the provision of this notification fails to improve his/her class/grade, his/her performance at such reappearance shall be ignored.
- If the candidate makes no improvement in the class, then earlier performance will be retained.
- A candidate will be allowed to reappear for the examination for improvement of class/grade within a period of three years from the date of his/her passing the degree examination.
- The candidate will be given maximum of three attempts for the improvement of his / her class.
- 12. The candidate who desires to apply for improvement of class should submit his / her application form for improvement of class from the College / School of Distance Education, Study Centre through which he / she has undergone the course. Form should be submitted for improvement before 31 August for the October / November examination season and 28 February for April/May examination season. No form for improvement of class shall be accepted after the prescribed dates for the respective/corresponding examination season.

CIRCULAR No. 265

The University has introduced Choice Based Credit System (CBCS) for all its postgraduate programmes from the academic year 2012-13.

As a second phase, it has been decided to introduce the CBCS for the undergraduates also from the academic year 2014-15.

In order to review the existing CBCS and to prepare a comprehensive rules for the CBCS, Hon'ble Vice Chancellor has constituted a Committee with Prof. S. F. Patil, former Vice Chancellor, BVU, Dr. P. M. Bulakh, Prof. M. S. Prasad and Mr. M. C. Khanwelkar.

The report of the Committee was placed before the Academic Council at its meeting held on 9th October, 2013 and 6th January, 2014. The Academic Council unanimously resolved to adopt the rules subject to the modifications wherever necessary by the respective Board of Studies and Faculties.

A copy of the rules are enclosed alongwith the erranda. The respective Board of Studies are requested to examine the rules and to offer their recommendations to the concerned Faculty. The Dean of each Faculty is requested to place the recommendations of the Board of Studies before the Faculty and to submit the final recommendation to the University.

The Board of Studies and the Faculty may consider the following points at the time of finalizing the rules for the CBCS.

- (1) It is of the opinion that the ATKT rules need not be a part of the Examinations Rules. However, the respective Boards and Faculties may decide.
- (2) The structure will be of three kinds namely, Core courses, Open Courses and General Courses.
- (3) The Core Courses should be of 70 to 75 percent of the credits, Open Courses should be of 20 to 25 percent and General Courses should be of 5 to 10 percent.
- (4) Each Board of Studies and Faculty should examine and decide the number of General Courses and the Open Courses to be offered.

The above points may be completed on priority basis and the final report may be submitted to the University for further action.

Choice Based Credit System and Grading Systems for Programmes offered by Bharati Vidyapeeth University

The University has introduced a Choice Based Credit System (CBCS) for all its Post-graduate programmes by 2012. Hon'ble Vice Chancellor is keen to bring all under graduate and other programmes also under CBCS from 2014. However, he wished to have a thorough review of the existing CBCS before extending it to all

Accordingly, as directed by Hon'ble Vice Chancellor, Dr. S. F. Patil, Dr. P. M. Bulakh, Shri. Madhav Khanwelkar, and Dr. M. S. Prasad held a meeting on Monday August 12, 2013 at 11.00 am to discuss and suggest modifications to the existing Credit and Grading Systems adapted by the University.

The report of the review committee was placed in the IQAC meeting on 10^{th} September 2013. Hon'ble Vice chancellor has directed to circulate the review committee report to all constituents of the University and seek their suggestions. The review committee held another meeting on 24th September to consider the suggestions received from the institutions and the IQAC, and to finalize the CBCS. The recommendations are as follows:

I. Uniform CBCS:

The University shall have a uniform grading and credit systems for all programmes that it offers across all the disciplines. If the suggested pattern is found to be inappropriate for any subject or discipline or faculty the concerned may, with justification, seek approval for any modifications to the suggested pattern as a special case from appropriate university authorities.

Credit Structure of Programmes:

A: Course Credit Structure: The following shall be the structure for curricula of various programmes under credit system. Every BoS and every Faculty has to put in maximum efforts to design a truly Choice Based Credit System. In this context, the committee lists the definitions of Choice Based Credit System and other terms provided by NAAC in March 2013, at

- 1. A program is a collection of courses that a student undertakes to obtain a certification from the University, in the form of a degree, diploma or certificate. Each course may be viewed also as a head-of-passing (HoP) for evaluation of the extent of learning. Each course is defined in terms of expected learning outcomes. The study load (the average number of clock hours per student needed to achieve the expected learning outcomes) determines the assigned credit or credit value for each course. The total of assigned credits of all courses is the assigned credit for the programme and this total constitutes the minimum credits required to be 'earned' to complete the programme and obtain the certificate, diploma or degree from the University.
 - 2. The minimum credits to complete a program shall be at the rate of 50 to 60 credits per year of the duration of the programme. Thus, a two year programme will have 100-120 credits; a three-year programme 150-180 credits; a four year programme 200-240 credits; and a five year programme 250-300 credits.
 - 3. A certificate course shall be of minimum 15 to 30 credits; a diploma of 30 to 60 credits; and a post-graduate diploma of 30-90 credits.
 - 4. The courses in a programme shall be majorly of three kinds, namely, core courses in the discipline of study and are either foundational or specializations. Core courses may either hard-core (courses which are compulsory to all students in the programme) or soft-core (courses which are electives). The hard-core courses also include laboratory courses, capstone courses such as internships, in-plant training or full-term projects.
 - 5. The core courses should be about 70-75% of the minimum credits that constitute the programme. Remaining 25-30% of the credits may be open courses or general courses. The open courses may be ancillary courses from other disciplines or other specializations or interdisciplinary. About 5-10% of the credits may be for general courses.
 - 6. General courses are expected to enhance knowledge about societal concerns or even may be value-added/ career development programmes. Even co-curricular and extra-curricular activities may be assigned credits.
 - 7. The Evaluation for all courses shall have two components Internal Assessment (IA) and End of the term University Examination (UE).

- 8. While assigning credit values to courses, one credit is considered to be equal to 15 hours of lectures and 25-35 hours of lab/ fieldwork/in-plant training/internship/ or any other.
- The curriculum of the programme must be truly choice based and should permit credit transfer between the academic departments in the institutes and in the University.
- 10. Credit may also be given for participation in extra-curricular activities. In each semester, there may be an extra-curricular/ co-curricular course of 2 or 3 credits. There will be a maximum of 10 credits at UG level and 5 credits at PG level. 25-30 hours of extra-curricular/co-curricular work may be considered as one credit.
- 11. For the time being, the policy for Credit Transfer is not specified by the University. Since credit transfer is an important component of CBCS, the individual BoS and Faculty should come up with suggestions for enabling both horizontal and vertical credit transfers.
- 12. The nature of question papers at UE and pattern of evaluations at IA courses shall be specified by the respective BoS and Faculty. However the marks assigned for attendance should not be more than absolute five for any course.
- 13. The grading system will be a 10-point absolute grading system.

III. Grading System for Various Programmes:

B. Grading System: The University shall adopt a 10-point absolute grading system for grading in each head of passing. The system will have seven grade points, the highest being 10. The grading system shall be as shown in Table-1 below. The performance indicators O, A+, A, B+, B, C, and D shall respectively mean Outstanding, Excellent, Very Good, Good, Average, Satisfactory, and Poor. It may be noted that entries in Table are meant for converting marks in individual courses to grade points. The respective grade points can also be computed from the following formulas given in Table-2.

The Formula to calculate the Grade Points (GP):

Suppose that 'Max' is the maximum marks assigned for an examination or evaluation based on which GP will be computed. In order to determine the GP, set x = Max/10 (since we have adapted 10-point system). Then GP is calculated by the formulas shown in Table-2. After computing the grade point the grade can be found from Table-1.

- C. Nature of Examinations: For all courses there shall be Internal Assessment (IA) conducted by the respective institutions and a end-of-the term University Examination (UE) conducted by the university. The UE will be based on the entire syllabus.
- D. Computation of Grade Point Averages: Cumulative performance indicators such as GPA, SGPA, or CGPA shall be calculated as described and illustrated below.

- The performances at UE and IA will be combined to obtain the Grade Point Average (GPA) for the course. The weights for performance at UE and IA shall respectively be 60% and 40%.
- 2. The grade point average (GPA) for a course shall be calculated by first finding the total marks out of 100 for the course. The corresponding GP (as per the table in (2) above) shall be the GPA for the course.
- 3. Two kinds of performance indicators, namely, the Semester Grade Point Average (SGPA) and the Cumulative Grade Point Average (CGPA) shall be computed at the end of each term. The SGPA measures the cumulative performance of a learner in all the courses in a particular semester, while the CGPA measures the cumulative performance in all courses since his/her enrolment. The CGPA of a learner when he/she completes the programme is the final result of the learner.
- 4. The SGPA is calculated by the formula $SGPA = \frac{\sum C_k \times GP_k}{\sum C_k}$, where C_k is the credit-value assigned to a course and GP_k is the GPA obtained by the learner in the course. In the above, the sum is taken over all the courses that the learner has undertaken for the study during the semester, including those in which he/she might have failed or those for which he/she remained absent. The SGPA shall be calculated up to two decimal place accuracy.
- 5. The CGPA is calculated by the formula $CGPA = \frac{\sum C_k \times GP_k}{\sum C_k}$, where C_k is the credit-value assigned to a course and GP_k is the GPA obtained by the learner in the course. In the above, the sum is taken over all the courses that the learner has undertaken for the study from the time of his/her enrolment and also the during the semester for which CGPA is calculated, including those in which he/she might have failed or those for which he/she remained absent. The CGPA shall be calculated up to two decimal place accuracy.
- 6. The CGPA, calculated after the minimum credits specified for the programme are 'earned', will be the final result.

E. Standards of Passing and ATKT rules:

 For all courses, both UE and IE constitute separate heads-of-passing (HoP). In order to pass in such courses and to 'earn' the assigned credits (a) the learner must obtain a minimum grade point of 5.0 (40% marks) at UE and also a minimum grade point of 5.0 (40% marks) at IA;

OR

(b) If he/she fails in IA, the learner passes in the course provided he/she obtains a minimum of 25% in IA and GPA for the course is atleast 6.0 (50% in aggregate). The GPA for a course will be calculated only if the learner passes at the UE. The following examples illustrate this rule for passing in a course under.

2. A student who fails at UE in a course has to reappear only at UE as a backlog candidate and clear the HoP. Similarly, A student who fails in a course at IA has to reappear only at IA as a backlog candidate and clear the HoP.

3. Subject to the Rules E1-E2, the ATKT and other rules may be framed by respective BoS and faculty.

. Award of Honours:

 A student who has completed the minimum credits specified for the programme shall be declared to have passed in the programme. The final result will be in terms of letter grade only and is based on the CGPA of all courses studied and passed. The criteria for the award of honours are given in Table 4.

2. Formula to compute equivalent percentage marks for specified CGPA:

G. Award of Grace Marks:

- 1. Grace marks of 1, 2, or 3 may be awarded to a candidate at UE only, so as to enable him/her to pass-in-a-head-of-passing either at UE or in aggregate. The grace marks may be given in at most two heads of passing in a semester. There shall not be gracing in IA. Total grace marks given in a semester shall be a maximum of five only. The GPA for a course will be calculated after awarding the grace marks.
- 2. Similarly, a grace of 0.05 GP may be added to the CGPA of the final semester after the student cleared all the heads-of-passing in the programme, so as to enable him/her to get a second class or higher second class or first class or distinction as the case may be.
- 3. Presently, the University is awarding **five bonus marks for** exemplary performance in extra-curricular activities. The present practice shall be continued. However, these marks shall be awarded at UE only before converting the UE marks to Grade points and Grades.

H. The format of the transcripts:

In every semester, the student will be given a transcript indicating his/her performance at the semester examination. The transcript shall show the performance indicators given in the following table, in addition to any other information.

IV. Glossary of Choice Based Credit System:

Academic flexibility is the [extent of] choice offered to the students in the curriculum offering and the curriculum transactions.

Beyond syllabus scholarly activities refers to Participation in academic activities beyond the minimum requirements of the syllabus.

Blended learning is to mix different learning environments such as traditional face-to-face classroom methods with modern computer-mediated activities.

Bridge course is a teaching module which helps to close the gap between two levels of competence.

Choice based credit system is a mode of learning in higher education which facilitates a student to have some freedom in selecting his/her own choices, across various disciplines for completing a UG / PG programme. It is popularly known as the cafeteria model.

Co-curricular activities are those ctivities, which support the curriculum such as field trips, display of academic achievements, quiz, debate, discussion, seminars, role-play, etc.

Course outlines is a list of the course modules, similar to a table of contents in a book or the outline used for writing papers. The outline defines the scope and content of the course.

Elective courses are a choice available to students to select from among a large number of subjects.

Enrichment courses are value added courses offered by institution for student empowerment. They enhance the curriculum by amplifying, supplementing and replacing such parts or features as have become ineffective or obsolete.

Extension activities are aspects of education, which emphasizes neighborhood services. These are often integrated with curricula as extended opportunities intended to help, serve reflect and learn. The curriculum-extension interface has educational values, especially in rural India.

Flexibility is a mechanism through which students have wider choices of programmes to choose from, as well as, multiple entry and exit points for programmes / courses.

Graduate Attributes are qualities, skills and understandings a university community agrees its students should develop during their time with the institution. These attributes include, but go beyond, the disciplinary expertise or technical knowledge that has traditionally formed the core of most university courses. They are qualities that also prepare graduates as agents for social good in an unknown future.

Learning outcomes are specific intentions of a programme or module, written in clear terms. They describe what a student should know, understand, or be able to do at the end of that programme or module.

Outreach activities are the practice of conducting local public awareness activities through targeted community interaction. They are guided by a local needs assessment.

Program options are a range of courses offered to students to choose at various levels leading to degrees/ diplomas/certificates.

Remedial courses are courses offered to academically disadvantaged students in order to help them cope with academic requirements.

- Ov. Criteria like educational qualification, marks scored, age or other such restrictions for the scribe/reader/lab assistant should not be fixed. Instead, the invigilation system should be strengthened, so that the candidates using scribe/reader/lab assistant do not indulge in malpractices like copying and cheating during the examination.
- VI. There should also be flexibility in accommodating any change in scribe/reader/lab assistant in case of emergency. The candidates should also be allowed to take more than one scribe/reader for writing different papers especially for languages.
- VII. Persons with disabilities should be given the option of choosing the mode for taking the examinations i.e. in Braille or in the computer or in large print or even by recording the answers as the examining bodies can easily make use of technology to convert question paper in large prints, e-text, or Braille and can also convert Braille text in English or regional languages.
- VIII. The candidates should be allowed to check the computer system one day in advance so that the problems, if any in the software/system could be rectified.
- IX. The procedure of availing the facility of scribe should be simplified and the necessary details should be recorded at the time of filling up of the forms. Thereafter, the examining body should ensure availability of 'question papers in the format opted by the candidate as well as suitable seating arrangement for giving examination.
- X. The disability certificate issued by the competent medical authority at any place should be accepted across the country.
- XI. The word "extra time or additional time" that is being currently used should be changed to "compensatory time" and the same should not be less than 20 minutes per hour of examination for persons who are making use of scribe/reader/lab assistant. All the candidates with disability not availing the facility of scribe may be allowed additional time of minimum of one hour for examination of 3 hours duration which could further be increased on case to case basis.
- XII. The candidates should be allowed to use assistive devices like talking calculator (in cases where calculators are allowed for giving exams), tailor frame, Braille slate, abacus, geometry kit, Braille measuring tape and augmentative communication devices like communication chart and electronic devices.

Shri Gopal Sisodia, General Secretary, Indian Association of the Blind, the Complainant filed a complaint dated 13.5.2007 (Case No. 3929/2007) under the Persons with Disabilities

yet to commence. However, the matter was under active consideration as views of certain National Associations in this field had been received and were being deliberated upon. It was also stated that all efforts to finalize the policy were being made.

- 5. This Court vide letter dated 04.09.2012 requested Department of Disability Affairs to Issue the guidelines on or before 20.09.2012, falling which, it was stated, this Court may be constrained to issue Show Cause Notice. Accordingly, as the guidelines were not issued, a notice of complaint to show cause and hearing was issued on 21.9.2012 with the advice to issue the guidelines by 20.10.2012; else to appear before this Court on 2.11.2012. The matter was rescheduled for hearing on 20.11.2012 on the request of Department of Disability Affairs.
- 7. During the hearing on 20.11.2012, the representative of Score Foundation in case No.66/1041/12-13 reiterating his submissions envisaged in his complaint dated 23.4.2012, stressed the need for Issuance of uniform and comprehensive guidelines for persons with bindness and persons with low vision as they continue to be routinely subjected to untold hardship and disadvantage for want of such uniform and comprehensive guidelines. He further submitted that the document which has been put together by Score Foundation and others could be circulated to all concerned as guidelines so that these guidelines can be used as a reference by various stake holders for developing their own norms with regard to conduct of examinations as stated above in respect of candidates with disabilities. The complainant further stated that several of the bodies conducting examinations are unaware of ways in which candidates with blindness and/or with low vision can be included in the examination process. He further added that several examination conducting Authorities under-estimate the capabilities of blind and low vision persons to participate in the examination process.
- The representative of Department of Disability Affairs, Ministry of Social Justice & Empowerment, Government of India submitted that the guidelines forwarded by Chief Commissioner for persons with disabilities were being considered by the Ministry. He added that before taking a linal view in the matter, the Ministry had convened a meeting with the recruitment authorities/agencies like Staff Selection Commission, Union Public Service Commission, CBSE and sensitized them about the proposed guidelines. These authorities were requested to send the detailed comments on each of the points made by the Chief Commissioner for persons with disabilities so that their implementation is ensured. While the comments of these authorities/agencies were received, the subsequent meeting to be held with them to finalize the matter could not be held. It was also decided by the Ministry to request the National Institutes working under the Ministry to organize consultations to discuss the guidelines tramed by Chief Commissioner for Persons with Disabilities. Even this consultation could not be held so far. Recently, on receipt of a reference from Score Foundation, the matter was again examined at the highest level and it was decided to take action on the guidelines framed by Chief Commissioner for Persons with Disabilities for reaching its logical conclusion. He further stated that a meeting would be convened in the middle of December this year with the relevant recruitment and

I am directed to refer to your letter No. 12635 dated 12.03.2013 on the above mentioned subject seeking clarification on clauses IV, V, VI, VII, VIII, XI and XV of the guidelines issued vide Ministry of Social-Justice and Empowerment, Department of Disability Affairs's OM No. 16-110/2003 DD-III dated 26.02.2013. The said guidelines are comprehensive and self explanatory, if and when any issue arises in their implementation, the same may be resolved by relying on the principle of need-based flexibility, keeping in view the need for providing reasonable accommodation or by referring the same to Ministry of Social Justice and Empowerment, Department of Disability Affairs.

Regarding clause XI, the facility of scribe/reader/lab assistant is meant for only those
candidates with disabilities who have physical limitation to write including that of speed. The
additional time would be applicable only to such candidates.
